Proceedings of the 32nd Annual General Meeting

The 32nd Annual General Meeting (“Meeting”) of Nuvama Wealth Finance Limited (“the Company”) for the FY 2026 was held today i.e. on Thursday, September 10, 2026, at 12 Noon (IST) at the Registered Office of the Company situated at 801- 804, Wing A, Building No. 3, Inspire BKC, G Block, Bandra Kurla Complex, Bandra (East), Mumbai – 400 051.

The Company Secretary welcomed all the Members present at the Meeting and informed them about the availability of all requisite statutory registers and other relevant documents.

Further, in accordance with Section 104 of the Companies Act, 2013 and the Articles of Association of the Company, Mr. Birendra Kumar, Independent Director and Chairperson of the Board of the Company, took the Chair.

The Chairperson then introduced to the Members, the Directors present at the Meeting and thereafter informed the name of the Directors who could not attend the Meeting due to preoccupation.

The Chairperson declared that 6 Members representing the 1,39,59,104 Equity Shares constituting 99.99% of the paid- up share capital of the Company were present at the Meeting. Accordingly, it was ascertained that the requisite quorum was present for the Meeting.

The Chairperson informed that the Notice for the Meeting and the Annual Report for the FY 2026 had been sent to Members of the Company. Thereafter, the Notice convening the Meeting was taken as read.

Further, the Chairperson informed that there were no qualification(s), observation(s) or comment(s) of the Statutory Auditor in their Report(s) for the financial year ended March 31, 2026 and the same were also taken as read.

The Chairperson then provided general instructions to the Members present, regarding participation and voting at the Meeting.

Mr. Karan Sahani, representative of M/s. Sahani and Kothari, Associates, Company Secretaries, was appointed as the Scrutinizer for the Meeting.

Thereafter, following items of business, as per the Notice convening the AGM, were transacted at the Meeting:

Sr. No.	Particulars of Resolution
1.	To consider and adopt the Audited Financial Statements of the Company for the financial year ended March 31, 2026, together with the Reports of the Board and Auditors thereon.
2.	To appoint Mr. Ramesh Abhishek (DIN: 07452293), who retires by rotation and being eligible, offers himself for re-appointment.
3.	To appoint M/s. SVVS & Associates Company Secretaries LLP, (Peer Review No. 5764/2024), Practicing Company Secretaries as the Secretarial Auditors of the Company for a period of 5 years.
4.	To re-appoint Mr. Birendra Kumar (DIN: 00163054) as an Independent Director of the Company for a second term of 3 years.

The Chairperson then concluded the Meeting and informed the Members that the resolutions as set forth in the Notice were open for voting by Poll.

All Members present in the Meeting submitted their responses to the Scrutinizer.

After scrutiny of the same, the Scrutinizer submitted his report to the Chairperson.

The Chairperson informed the Members that the Company had received assent from all the eligible Members with respect to all the above resolutions.

The Chairperson thanked the Directors and Members for participating in the Meeting.

The Meeting commenced at 12 Noon and concluded at 12:30 p.m. with vote of thanks to the Chair.
